## 08/08/20 Matters of Report

- 1. Chairman Colin Allen and Vice Chairman Mike Phillips have agreed to remain in post until the annual meeting in May 2021
- 2. Councillors Posts of Responsibilities and Committee memberships will continue until May 2021
- Planning application 13/20/00017, erection of a garage on site of existing (to be demolished) at 23 Mill Lane has recently been received and circulated to all Councillors. Cllr Mike Phillips proposed to support this application which was unanimously agreed.
- 4. Child of Cannington Award This award is normally given out at the Annual Parish meeting which didn't take place this year. Councillors were unanimous that this award should be presented this year.
- 5. Government Small Business Grant. Councillors unanimously agreed to apply for this grant.
- 6. East and West Roundabouts. Providing Highways gives its consent, Councillors agreed to seek quotes/suggestions for the clearing and replanting of the roundabouts.
- 7. COVID-19 emergency budget. A request is expected from Cannington Volunteers to contribute towards volunteers' mileage allowances. This was wholeheartedly supported by Councillors.
