01/02/22 Declarations of Members Interests

There were no declarations of members' interests

Public Session

Items raised in the public session included:

- Concerns were once again raised about the safety of Mill Lane. Highways have been contacted regarding this and no further action can be considered until Highways have reported back.
- It was noted that pedestrians should take priority over traffic and this has been addressed in changes to the Highway Code
- It was reported that 'no waiting signs' are missing on posts in Duke Avenue and Brook Street. This will be reported to Highways
- A member of Cannington in Bloom reported that they have 3 designs for the sign to go on the welcome features at 2 entrances to the village. These were circulated to councillors for consideration.
- It was reported that advisory notices had been spotted on parked cars in the village. It was assumed these had been placed by the HPC flyparking team.

04/02/22 Matters Arising

There were no matters arising not covered by a separate agenda item.

05/02/22 Planning matters

New planning applications

- 1. **13/21/00041** Installation of groundmount PV (Solar Panels) to provide carbon free electricity at Yeo Valley. After lengthy discussions councillors were mindful to support the application if certain points are clarified to our satisfaction. This was proposed by Cllr Alan Beasley, seconded by Cllr Steve Pettitt and agreed unanimously.
- 2. **13/22/00001** Erection of a two-storey extension to the side (SW) elevation, single storey extension to the rear (NW) elevation and erection of a front porch at 9 Southbrook. Cllr Steve Pettitt proposed to support this application. This was seconded by Cllr Alan Beasley and agreed unanimously.
- 3. **13/22/00002** Erection of a first-floor extension to the side (SW) elevation and formation of porch at 24 Brownings Road. Cllr Kym Wardhaugh proposed to support this application. This was seconded by Cllr Ian Dyer and agreed unanimously.
- 4. **13/22/00003** Retention of public house and reinstatement of cottage adjoining the public house at 30 High Street. This application arrived too late to be put on the agenda. Cllr Robin Phipps proposed to support this application (once it had been advertised on the notice boards and no concerns are raised by members of the public). This was seconded by Cllr Kym Wardhaugh and agreed unanimously

- 13/20/00029 Change of use and extension of outbuilding (barn) to a dwelling at Chilton Trivett Farm, Blackmore Lane. Permission granted
- 2. 13/21/00012 Conversion of outbuilding to dwelling at Chilton Trivett Farm, Blackmore Lane. Permission granted
- 3. **13/21/00040** Notice of proposed agricultural development Application to determine if prior approval is required for a proposed erection of an agricultural building at Hensfield Farm, Chads Hill. **Formal application not required**

06/02/22 Reports (as applicable)

- 1. Highways and Parking Issues
 - Bollards on High Street. A request has been made to Highways to reposition the bollards on the pavement.

- Concerns were raised that this would then encourage parking on the other side of the bollards. Suggestions raised included installing a second row of bollards and/or paint hatching or 'no parking' on the pavement
- Double Yellow Lines (DYL) Brook Street Highways have confirmed that they will apply to put DYL on both sides of the Turnpike bridge and to extend the existing DYL in front of the cottages.
- Mill Lane one-way system not suitable. As discussed in the public session Highways will be contacted to see if there is anything that can be done to improve Mill Lane for pedestrians and vehicles
- Footpaths
- Neighbourhood Plan 3.
- Cannington Court 4.
 - The recent increase in electricity usage at the pavilion is due to the security lights censor being faulty, this is due to be replaced shortly.
 - A meeting has been arranged for 24th February to discuss the possible car park extension.
- EDF Community Forum held on 20th January 2022 5.
 - Unfortunately, no one was able to attend for Cannington. The notes from the meeting have been circulated to all councillors
- Speed Indicator Device
 - The Clerk has written to SCC asking for the criteria for a permanent SID
- Queen's Platinum Jubilee
 - Cannington in Bloom will be organizing a tea party trail, it is hoped for 70 planted tea cups to represent the 70 years of the Queen's reign.
 - Bunting is being considered for Jubilee Gardens
 - A tea party has been suggested in Jubilee Gardens on Sunday 5th June 2022
 - A suggestion was made for medals or similar for all primary school children. Cllr Kym Wardhaugh volunteerd to research this.
 - It is uncertain whether an Oak tree would be suitable to be planted in Jubilee Gardens. If not, a Liquid Amber was agreed as an alternative, or consider another location for an Oak tree.

07/02/22 Correspondence and issues to discuss

- 1. Cannington Enterprises Several reports of bad odour have been reported during January 2022. The Environment Agency has investigated the complaints and found a few issues for the operator to rectify. No further odours have been reported.
- Somerset Bus Partnership meeting was held on 17th January 2022 and attended by Roy Pumfrey. The notes from the meeting have been circulated.
- Grant application Cannington Brownies
 - A request has been received for £500 to assist with the annual payment to Brownie Headquarters. It was noted that there was insufficient budget under donations, but budget could be transferred from the contingencies budget. Cllr Ian Dyer proposed we award £500. This was seconded by Cllr Robin Phipps and agreed unanimously.
- 4. Sedgemoor CAB donation request. Councillors unanimously agreed to make a donation of £200.
- Correspondence has been received from a resident suggesting the speed limit of the C182 should be reduced if the new access on to the C182 for Cannington Quarry is approved. It was noted that if the speed needed to be reduced then the planning application would not be granted.
