Public Session

Chairman Colin Allen welcomed everyone to the last meeting of the current council. The elections will take place on 5th May 2022 and three of the current councillors will not be standing for re-election. 17 candidates have come forward for election and it will be the first Parish Council elections since 2011.

03/04/22 Minutes of Meeting held on 8th March 2022

05/04/22 Planning matters

SDC Cllr Brian Bolt left the meeting for this agenda item

- New Planning applications
 - 13/22/00004 Non-material amendments for Grange Farm development, confirmation that the layout and house type drawings will take primacy over the inaccurate street scene drawings will not materially alter the character of the approved scheme. For information only. Permission granted

- 1. **13/21/00031** Erection of dwelling at The Granary Blackmore Lane. **Refused**
- 2. 13/21/00041 Installation of solar panels at Yeo Valley. Development Committee deferred decision
- 3. 13/22/00003 Retention of public house and re-instatement of cottage at 30 High Street. Permission granted.
- 4. 13/22/00005 Works to Horse Chestnut at 27 Rodway. Permission granted

Following recent press coverage of new developments removing the affordable housing provision once planning permission has been granted, SCC Cllr Mike Caswell emphasised the need for a robust S106 agreement to deliver the affordable housing and a local lettings agreement is vital.

06/04/22 <u>Reports (as applicable)</u>

1. Highways and Parking Issues

- Bollards on High Street. We are still waiting a response from Highways; we are also in discussions with the Police as to the best way to resolve the on-going parking issues
- Mill Lane. Highways will carry out an inspection of the existing road lining and signs to see whether anything requires refurbishing.
- Concerns have been raised that there is a need for additional/larger dog bins. It was agreed to put a bin at the top of Chads Hill and to review the existing locations.
- Traffic Calming. Plans have been received for the upgrading of existing speed cushions with table tops and additional ones on Rodway. The costings for this project are still to be finalised.
- Discussions previously took place with South West Heritage to look at new and refurbished traditional style finger posts for Cannington. This will be followed up by the clerk.

2. Footpaths

- The gate at Gurney Street end of the public footpath running alongside the school needs attention.
- A bridge on the Parrett Way footpath is in a dangerous state. This is a permissive path on land owned by the College.

- 3. Neighbourhood Plan
- This must be included on every agenda and needs to be the number one priority for the new council.
- 4. Cannington Court
 - We are still waiting for a response from SDC planners regarding the car park extension at Rodway.
- 5. Speed Indicator Device (SID)
 - The downloading of the data has still not been resolved.
 - It is hoped than when the new council is formed in May that a subgroup can be responsible for the SID
 - A request for the criteria for a permanent SID has been made to Highways
- 6. Queen's Platinum Jubilee
 - Celebrations on 4th June 2022.
 - Notes of the meeting held on 5th April have been circulated to all Councillors and the arrangements for the day are coming together.
 - \checkmark It was agreed for the celebrations to start at 2.00pm.
 - Details of the event will be advertised in the Target due out at the beginning of May. Further advertising will take place nearer the time.
 - ✓ It was strongly stated that fireworks would not be allowed in Jubilee Gardens
 - A drumming group is available on 4th June. It involves audience participation, the costs are £250 for 1hr or £350 for 2hrs. Cllr Mike Phillips proposed to book the group for 1hr, this was seconded by Cllr Alan Beasley and agreed by a majority.
 - The new flagpole for Jubilee Gardens has now been received and will be erected shortly.
 - 200 Platinum Jubilee coins have been ordered for all Primary School age children
 - Transport Forum held on 17th March 2022
 - Cllr Rob Morgan attended this meeting; his notes have been circulated to councillors and there was nothing of concern to report.
- 8. Parish Council and Unitary elections
 - As stated in the public sessions these are taking place on Thursday 5th May 2022
 - SCC Cllr Mike Caswell said it had been an absolute joy working with the councillors at Cannington. Cllr Mike Phillips had been a stalwart of the Hinkley Point SSG meetings and has always asked the right and in some cases difficult questions
- 9. Somerset Bus Partnership
 - The latest meeting was held on 24th March 2022 and was attended by Roy Pumfrey
 - On 15th March 2022 the Government announced its Bus Strategy. Its central aim is to get more people travelling by bus.
 - Somerset says it will continue to work with operators to maintain services and is seeking £163 million from the Government compared with its current £3million spend
